Jose C. Fraga, being duly sworn, deposes and says:

1. I am a Senior Director of The Garden City Group, Inc. ("GCG"). GCG was appointed by Skadden, Arps, Slate, Meagher & Flom LLP to mail, pursuant to the scheduling order entered by the Court on October 31, 2012, the Notice of Pendency of Class Action, Proposed Settlement and Settlement Hearing (the "Notice") to all record holders of common stock of Amerigroup Corporation ("Amerigroup") as of October 31, 2012, that were members of

the Class (as defined in the scheduling order). A true and correct copy of the Notice is attached hereto as Exhibit A.

2. On or about November 2, 2012, GCG received from Defense Counsel, the names and addresses of all record holders of Amerigroup common stock as of October 31, 2012. There were a total of 51 such record holders.

3. On November 15, 2012, GCG mailed by first-class mail, postage prepaid, a Notice to each of these 51 record holders.

4. In the aggregate, from November 16, 2012 to December 27, 2012, GCG mailed 54 Notices to potential nominees and Class members by first-class mail, postage prepaid. This includes 3 Notices that were remailed due to updated addresses provided by the U.S. Postal Service.
