(the "Initial Mailing Declaration"). I have personal knowledge of the facts set forth herein and, if called as a witness, could and would testify competently thereto.

### MAILING OF THE NOTICE PACKET

2. Since the execution of my Initial Mailing Declaration, Analytics has continued to disseminate copies of the Notice and Claim Form (the "Notice Packet") in response to additional requests from potential members of Settlement Class, brokers, and nominees. Through July 18, 2018, Analytics has mailed a total of 44,509 Notice Packets to potential Settlement Class Members and nominees.

#### TELEPHONE HELPLINE AND WEBSITE

3. Analytics continues to maintain the toll-free telephone number (1-844-327-3154) and interactive voice response system to accommodate any inquiries from potential members of the Settlement Class. Analytics also continues to maintain the dedicated website for the Action (<a href="www.InsuletSecuritiesLitigation.com">www.InsuletSecuritiesLitigation.com</a>) in order to assist potential members of the Settlement Class. On June 4, 2018, Analytics posted to the website copies of the papers filed in support of Lead Plaintiffs' motion for final approval of the Settlement and Plan of Allocation and Lead Counsel's motion for an award of attorneys' fees and expenses. Analytics will continue maintaining and, as appropriate, updating the website and toll-free telephone number until the conclusion of the administration.

#### REPORT ON REQUESTS FOR EXCLUSION RECEIVED

4. The Notice informed potential members of the Settlement Class that requests for exclusion from the Settlement Class were to be mailed or otherwise delivered, addressed to *Insulet Corp. Securities Litigation* EXCLUSIONS, c/o Analytics Consulting LLP, P.O. Box 2007, Chanhassen, MN 55317-2007, such that they were received by no later than July 3, 2018.
