**SUPPLEMENTAL DECLARATION OF
ERIC J. MILLER REGARDING:
(A) MAILING OF THE NOTICE AND
CLAIM FORM; AND (B) REPORT ON
REQUESTS FOR EXCLUSION RECEIVED**

1 I, ERIC J. MILLER, declare:

2 1. I am a Senior Vice President of A.B. Data, Ltd.’s Class Action Administration
3 Company (“A.B. Data”). Pursuant to the Court’s July 29, 2020 Order Preliminarily Approving
4 Settlement and Authorizing Dissemination of Notice of Settlement (ECF No. 93) (the
5 “Preliminary Approval Order”), A.B. Data was authorized to act as the Claims Administrator in
6 connection with the Settlement of the above-captioned action (the “Action”).¹ I submit this
7 Declaration as a supplement to my earlier declaration, the Declaration of Eric J. Miller Regarding:
8 (A) Mailing of the Notice and Claim Form; (B) Publication of the Summary Notice; and (C)
9 Report on Requests for Exclusion Received to Date, dated September 24, 2020 (ECF No. 99-4)
10 (the “Initial Mailing Declaration”). I have personal knowledge of the facts set forth herein and, if
11 called as a witness, could and would testify competently thereto.

12 **CONTINUED MAILING OF THE NOTICE PACKET**

13 2. Since the execution of my Initial Mailing Declaration, A.B. Data has continued to
14 disseminate copies of the Notice and Claim Form (together, the “Notice Packet”) in response to
15 additional requests from potential Settlement Class Members and nominees. Through November
16 10, 2020, A.B. Data has mailed a total of 81,225 Notice Packets to potential Settlement Class
17 Members and nominees.

18 **TELEPHONE HELPLINE AND WEBSITE**

19 3. A.B. Data continues to maintain the toll-free telephone number (1-877-869-0158)
20 and interactive voice response system to accommodate any inquiries from potential members of
21 the Settlement Class. A.B. Data also continues to maintain the dedicated website for the Action
22 (www.ImpinjSecuritiesLitigation.com) in order to assist Settlement Class Members. On
23 September 25, 2020, A.B. Data posted to the website copies of the papers filed in support of Lead
24 Plaintiff’s motion for final approval of the Settlement and Plan of Allocation and Lead Counsel’s

1 motion for an award of attorneys' fees and expenses. On November 4, 2020, A.B. Data updated
2 the website to inform Settlement Class Members that the hearing concerning final approval of the
3 Settlement would be conducted by telephone and instructed them to contact Lead Counsel if they
4 wish to participate in or listen to the hearing. A.B. Data will continue maintaining and, as
5 appropriate, updating the website and toll-free telephone number until the conclusion of the
6 administration.

7 **REPORT ON REQUESTS FOR EXCLUSION RECEIVED**

8 4. The Notice informed potential members of the Settlement Class that requests for
9 exclusion from the Settlement Class were to be mailed or otherwise delivered, addressed to *Impinj*
10 *Securities Litigation*, EXCLUSIONS, c/o A.B. Data, Ltd., P.O. Box 173001, Milwaukee, WI
11 53217, such that they were received by no later than October 29, 2020. A.B. Data has been
12 monitoring all mail delivered to that post office box. As of the date of this Declaration, A.B. Data
13 has received a total of eleven (11) requests for exclusion. Of those requests for exclusion, one
14 (1), from Ronald E. Kister, was received after the October 29, 2020 deadline. Exhibit 1 hereto
15 lists the names of the persons who have requested exclusion from the Settlement Class and their
16 city and state.

17 I declare, under penalty of perjury, that the foregoing facts are true and correct.
