common stock during the Class Period for the beneficial interest of persons or organizations other [PROPOSED] ORDER REGARDING DISSEMINATION OF SUPPLEMENTAL CLASS NOTICE

1. On May 8, 2020, the Court certified this action as a class action under Rule 23 of the Federal Rules of Civil Procedure. (Dkt. No. 227.) On May 29, 2020, the Court approved the dissemination of notice of the pendency of the Action as a class action, and appointed the firm of A.B. Data, Ltd. ("A.B. Data") to supervise and administer the notice procedure. (Dkt. No. 242.)

- 2. Beginning on June 19, 2020, A.B. Data mailed a total of 126,828 copies of the Court-approved Class Notice to all potential members of the Class who had been identified by Defendants and by banks, brokers, and nominees. (Dkt. No. 256, at ¶¶ 4-8.) The Notice Administrator also published the Summary Class Notice in The Wall Street Journal and The Financial Times and over the PR Newswire on July 6, 2020. (Id. at ¶ 9.) The Class Notice and Summary Class Notice informed Class Members that any request for exclusion from the Class must be postmarked no later than August 25, 2020. (*Id.* at Exs. A-D). The Notice Administrator received 49 requests for exclusion from the Class. (*Id.* at ¶ 12 and Ex. E.)
- 3. On April 20, 2021, the Court ordered that a supplemental notice be mailed to members of the Class (a) informing them of the circumstances described in a recent order of the Court dated April 20, 2021, including that Class Counsel hired Hans Ek, the former Deputy Chief Executive Officer of Lead Plaintiff SEB Investment Management AB; and (b) affording Class Members a second opportunity to request exclusion from the Class. (Dkt. No. 380.)
- 4. No later than twenty (20) business days after the Court's approval and entry of this Order (the "Supplemental Notice Date"), A.B. Data shall send, by first class mail, the agreed-upon proposed Supplemental Notice of Pendency of Class Action (the "Supplemental Notice"), substantially in the form attached hereto as Exhibit A, to all potential Class Members who may be identified through reasonable effort, including all persons and entities who were previously mailed a copy of the Class Notice. For all Supplemental Notices returned as undeliverable, A.B. Data shall search the National Change of Address Registry and resend within three business days of receiving the envelope back as undeliverable. Nominee Procedures – In connection with the previous dissemination of the Class

Notice to members of the Class, brokers and other nominees ("Nominees") were advised that, if

they purchased or otherwise acquired publicly-traded Symantec Corporation ("Symantec")

than themselves, they must either: (a) within seven (7) calendar days of receipt of the Class Notice, request from A.B. Data sufficient copies of the Class Notice to forward to all such beneficial owners and within seven (7) calendar days of receipt of those Class Notices forward them to all such beneficial owners; or (b) within seven (7) calendar days of receipt of the Class Notice, provide a list of the names and addresses of all such beneficial owners to A.B. Data.

- (a) For Nominees who chose the first option (*i.e.*, elected to mail the Class Notice directly to beneficial owners), A.B. Data shall forward the same number of Supplemental Notice to such Nominees by May 21, 2021, Notice Date, and the Nominees shall, by June 4, 2021 within seven (7) calendar days of receipt of the Supplemental Notices, mail the Supplemental Notices to the beneficial owners;
- (b) For Nominees who chose the second option (*i.e.*, provided a list of names and addresses of beneficial holders to A.B. Data), A.B. Data shall, by the Supplemental Notice Date, mail a copy of the Supplemental Notice to each of the beneficial owners whose names and addresses the Nominee previously supplied. Unless the Nominee purchased or acquired publicly-traded Symantec common stock during the Class Period for beneficial owners whose names and addresses were not previously provided to A.B. Data, such Nominees need not take any further action;
- the Class Period for beneficial owners whose information was not previously provided to A.B. Data, Such Nominees shall endeavor to send notices as promptly as possible.

 A.B. Data, Such Nominees shall within seven (7) calendar days of receipt of promptly

 Supplemental Notice, provide a list of the names and addresses of all such beneficial owners to A.B. Data, or shall request from A.B. Data sufficient copies of the Supplemental Notice to forward to all such beneficial owners which the Nominee shall, within seven (7) calendar days of receipt of the Supplemental Notice from A.B. Data, mail to the beneficial owners; and this process shall be completed by June 4, 2021, the supplemental notice date."
- (d) Upon full and timely compliance with this Order, Nominees who mail the Supplemental Notice to beneficial owners may seek reimbursement of their reasonable expenses actually incurred in complying with this Order by providing A.B. Data with

proper documentation supporting the expenses for which reimbursement is sought. Such properly documented expenses incurred by Nominees in compliance with the terms of this Order shall be paid by Class Counsel, with any disputes as to the reasonableness or documentation of expenses incurred subject to review by the Court.

- 6. In addition, A.B. Data shall post the Supplemental Notice to the website previously established for the Action, www.SymantecSecuritiesLitigation.com, and Class Counsel shall post the Supplemental Notice on its website, www.blbglaw.com, by May.21, 2021, Also by May.21, 2021, 2021,
- 7. Within ten (10) business days after the Supplemental Notice Date, A.B. Data shall cause the Summary Supplemental Notice, substantially in the form attached hereto as Exhibit B, to be published in *The Wall Street Journal* and *The Financial Times* and to be transmitted over *PR Newswire*.
- 8. The Supplemental Notice shall provide an address for the purpose of receiving additional requests for exclusion from the Class. The requests for exclusion from the Class shall be made by submitting a written request for exclusion as set forth in the Notice and shall be no later than July 2, 2021 postmarked within forty-five (45) calendar days after the Supplemental Notice Date (the "Exclusion Date"). Persons and entities who previously requested exclusion from the Class in connection with the original Class Notice are not required to re-submit a request for exclusion to remain excluded from the Class.
- 9. A.B. Data shall (a) identify and number all additional exclusion requests received and create copies of those requests for counsel for all parties; (b) provide via email weekly reports of additional exclusion requests received to counsel for all parties; and (c) maintain the original requests in its files.
- July 19, 2021, at midnight, 10. No later than fifteen (15) business days after the Exclusion Date, Class Counsel shall file with the Court proof of mailing of the Supplemental Notice, proof of publication of the Summary Supplemental Notice, and an affidavit setting forth a list of all additional persons and entities who have requested exclusion from the Class.
- 11. The costs of this supplemental notice process shall be borne by Class Counsel and not by Lead Plaintiff, the Class, or Defendants.

12. The exterior of the envelope for the mailing notice shall state "Important Class Action Notice" and shall clearly identify the mailing as coming from the United States District Court, Northern District of California, Honorable William Alsup, 450 Golden Gate Avenue, San Francisco, CA 94102, with the return address as Claims , c/o , P.O. Box XXXXX, XXXXX-XXXX. Administrator, , c/o 13. This Order may be modified by the Court upon motion by either or both parties, for good cause shown. IT IS SO ORDERED.
