A Conversation with Legal and Responsible Investment Professionals in a Rapidly Evolving Landscape

The importance of ESG for institutional investors and the companies they invest in is not new, but the trend appears to be accelerating. The decision of the District Court of The Hague ordering Royal Dutch Shell to reduce its CO 2 emissions by 45% by 2030, as compared with 2019 levels, sets a precedent for other companies that could face similar lawsuits. Climate change litigation is here to stay. Growing climate awareness, increased pressure on Governments to adopt progressive legislative and regulatory action to try to limit global warming to "well below" two degrees (if not 1.5 degrees), and to take actual concrete steps now to implement these targets in the short to medium term, make this an efficient tool for investors and activists to apply pressure on businesses. These trends and corresponding demands on institutional investors by stakeholders, beneficiaries, and the media, provide opportunities for legal and responsible investment professionals to support their organizations' purpose, promote sustainable development, and contribute to the future success of investee companies.

15:00 – 15.45 Panel: Non-U.S. Remedies for Investors

Although 92% of global securities litigation recoveries are the result of U.S. class actions, other jurisdictions are of growing importance to investors and are increasingly providing avenues for investors to recover losses. We will discuss the selection and retention of counsel; payment of attorneys' fees; litigation costs and upfront fees; the implications of "loser-pay" fee-shifting rules and obtaining proper insurance coverage; different litigation funding models; contingent and other "success fees;" affirmative client obligations with respect to discovery, depositions, court attendance or other aspects of case prosecution; the ability of investors to oversee case strategy and settlement; negotiation of the terms of retention; and procedures for payment of recovery.
