# More top recoveries than any other firm

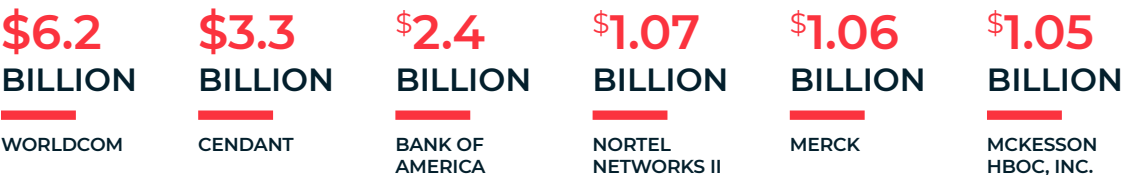
## ISS Securities Class Action Services (ISS SCAS)

The ISS SCAS *Top 100 U.S. Class Action Settlements of All-Time* report shows BLB&G with more top securities recoveries than any other firm. We've been ranked number 1 in the report for over a decade, since its inception. The report highlights a number of key metrics that illustrate BLB&G's track record of success for institutional investor plaintiffs:

- BLB&G served as lead or co-lead counsel in nearly 40% of the top 100 securities fraud settlements—more than twice as many cases as any other firm.
- BLB&G has secured six settlements over \$1 billion—more than any other firm.
- Of the settlements included, BLB&G has recovered more than \$26 billion for shareholders — approximately \$10 billion more than the nearest competitor. We have recovered more than \$37 billion overall.

The SSLA data shows that in 85% of BLB&G's cases, the courts uphold the complaint and deny defendants' motions to dismiss, the best track record of any securities litigation firm. These results are due in part to our specialized in-house team of financial analysts and financial investigators, who rigorously vet each potential case upfront to protect our clients' reputations and interests.

The SSLA data also shows that 75% of BLB&G's settlements occur in the discovery phase — more than our competitors. This is evidence that BLB&G prepares every case for trial, prosecutes the cases more thoroughly, and invests more resources to obtain superior results.
