- I, Josephine Bravata, being duly sworn, depose and say:
- 1. I am the Quality Assurance Manager of Strategic Claims Services ("SCS" or the "Notice Administrator"), a nationally recognized class action administration firm. I have over 20 years of experience specializing in the administration of class action cases. SCS was established in April 1999 and has administered over 525 class action cases since its inception. I have personal knowledge of the facts set forth herein, and if called on to do so, I could and would testify competently thereto.
- 2. I also have personal knowledge of the facts set forth in the Affidavit of Paul Mulholland, which was filed with the Court on June 7, 2023 (the "Mulholland Affidavit"), 1 and if called on to do so, I could and would testify

competently to the facts set forth in the Mulholland Affidavit. I incorporate by reference all of the facts set forth in the Mulholland Affidavit.

- 3. I submit this supplemental affidavit in order to provide the Court and the parties with updated information regarding the post card notices mailed to holders of AMC Common Stock.²
- 4. As noted in the Mulholland Affidavit, within five business days of receipt of a response from any nominee for beneficial holders of AMC Common Stock, SCS either mailed or emailed post card notices to such beneficial holders or provided the nominee with post cards to mail to such beneficial holders. Attached as **Exhibit A** is an updated list of the nominees who responded, when they responded, and when the mailing or emailing of the post card notice to beneficial holders of AMC Common Stock was completed. This is an updated version of Exhibit D to the Mulholland Affidavit. As of June 22, 2023, SCS and nominees for beneficial holders of AMC Common Stock mailed or emailed approximately three million post card notices to beneficial holders of AMC Common Stock.
- 5. Throughout the notification process, and as stated in the Mulholland Affidavit, SCS called and sent reminder notices to targeted nominees who did not respond within five business days of receiving the letter notifying them of the

Settlement, but who typically respond to securities class action settlement notices.

SCS has continued to follow-up with such nominees since the filing of the Mulholland Affidavit. Attached as **Exhibit B** is an updated chart showing SCS's follow-up efforts. This is an updated version of Exhibit E to the Mulholland Affidavit.

6. Out of the approximately three million post cards mailed to date, 95,608 were returned as undeliverable.³ Of these, the United States Postal Service provided forwarding addresses for 5,646, and SCS immediately mailed another post card notice to the updated addresses. The remaining 89,962 post card notices returned as undeliverable were "skip-traced" to obtain updated addresses, and 47,344 were re-mailed to updated addresses.


