2 PLEASE TAKE NOTICE that Lead Counsel Saxena White P.A. and  
3 Bernstein Litowitz Berger & Grossmann LLP (“Lead Counsel”) hereby move the  
4 Court pursuant to Rule 23(e) of the Federal Rules of Civil Procedure for an Order:  
5 awarding (1) attorneys’ fees in the amount equal to 30% of the Settlement Fund;  
6 (2) Lead Counsel’s litigation expenses incurred in prosecuting this Action in the  
7 amount of \$104,686.68; and (3) \$8,892.01 to Lead Plaintiffs as reimbursement for  
8 the value of the time their employees dedicated to representing the Settlement Class  
9 in this Action. Pursuant to Local Rule 7-3, and as set forth in the Stipulation of  
10 Settlement, Lead Counsel has met and conferred with counsel for Defendants, and  
11 Defendants do not oppose this motion.
