**NOTICE OF LEAD PLAINTIFF'S
MOTION FOR APPROVAL OF
DISTRIBUTION PLAN**

To: All persons on ECF service list:

PLEASE TAKE NOTICE that on December 16, 2019, at 11:00 a.m., Lead Plaintiff Arkansas Teacher Retirement System will move before the Honorable Peter G. Sheridan, U.S.D.J., at the Clarkson S. Fisher Judicial Complex, 402 East State Street, Trenton, New Jersey 08608, pursuant to Rule 23 of the Federal Rules of Civil Procedure, for entry of the accompanying [Proposed] Order Approving Distribution Plan (the “Class Distribution Order”), which would, *inter alia*: (i) approve the administrative determinations of the Claims Administrator, the Garden City Group, LLC (“GCG”), accepting and rejecting Claims submitted in connection with the Settlement reached in the above-captioned Action as stated in the Amin-Giwner Declaration; (ii) direct the distribution of the Net Settlement Fund to Claimants whose Claims are accepted by GCG as valid and approved by the Court (“Authorized Claimants”), while maintaining a Reserve for any tax liability and claims administration-related contingencies that may arise; (iii) direct that distribution checks state that the check must be cashed within 90 days after the issue date; (iv) direct that Authorized Claimants will forfeit all recovery from the Settlement if they fail to cash their distribution checks in a timely manner; (v) approve the recommended plan for any funds remaining after the distribution; (vi) approve GCG’s fees and expenses incurred and estimated to be incurred in the administration of the Settlement; (vii) release claims related to the administration process; and (viii)

authorize the destruction of Proof of Claim Forms and supporting documents at an appropriate time.

The undersigned intend to rely upon the annexed Memorandum in Support of Lead Plaintiff's Motion for Approval of Distribution Plan and the accompanying Declaration of Stephanie Amin-Giwner in Support of Lead Plaintiff's Motion for Approval of Distribution Plan (the "Amin-Giwner Declaration")¹ submitted on behalf of the Court-approved Claims Administrator, Garden City Group, LLC ("GCG").
